#### Purpose of Committee

The Finance & Investment Committee is being newly formed, taking over part of the role of the previous Finance, Audit & Risk Committee, as well as absorbing the responsibilities of the previous Investment Committee. Its purpose is to support the College Executive Board and the Chief Executive Officer by reviewing and making recommendations to the College Executive Board on the financial plans and financial performance of the College, staff remuneration policy, and investment policy and strategy, and implementing the College's investment strategy with the assistance of the College's Investment Advisors.

#### Overview of role

The Chair of the Finance & Investment Committee will work closely with College's President, Treasurer, CEO and Finance Director to guide the Committee in achieving its purpose.

The Chair of this Committee will also be a Trustee of College and a member of College's Executive Board.

This role is non-remunerated. Reasonable expenses will be reimbursed.

#### Time Commitment

The Chair will be required to attend a minimum of four Finance & Investment Committee meetings and six Executive Board meetings each year. The Chair may be invited to attend one or more meetings of College's Audit & Risk Committee each year, where financial risk matters or where College's external audit is being considered

Additional ad hoc meetings are also likely to be required.

The Chair of the Committee will be for a maximum of two three year terms.
