## **Draft Respiratory Care Action Plan for Scotland**

The Royal College of Physicians and Surgeons of Glasgow is pleased to support the principles of this document for the management of five long term Respiratory Conditions,

- Asthma
- Bronchiectasis
- Chronic Obstructive Pulmonary Disease (COPD)
- Idiopathic Pulmonary Fibrosis (IPF)
- Obstructive Sleep Apnoea Syndrome.

These are all causes of significant disability in the community and shorten life/ We are particularly please to see the section on Patient centred-care and self-management. However, the College believes that patients should have access to specialist care when necessary with initiation by the patient.

This consultation was initiated prior to the current COVID-19 Pandemic. The current experience is that many of the people who have had severe disease and have recovered will have long term Respiratory disease with impairment of lung function. This is in addition to the current cohort of patients with respiratory disease. There will need to be development of a similar care plan and NHS service to support these individuals and minimise disability and respiratory dysfunction. There appears to be a different susceptibility in People from a BAME (Black, Asian and Minority Ethnic) Background and if borne out the service may need to be tailored to that community.
