# President's reflections



# I never cease to be aware of the privileged position I find myself in as your President.

I express my thanks to our Chief Operating Officer, John Cooper, and our cohesive and committed staff. I also greatly value the considerable number of Fellows and Members in all five Faculties, who selflessly commit their time and expertise to our Royal College.

An example of this was our flagship international triennial conference, Advancing Excellence in Healthcare. We were delighted to have HRH The Princess Royal attend the event and her interest was evident. The theme of sports medicine and physical activity was particularly appropriate and we are now building on our commitment to this important aspect of healthcare with our recently appointed leadership fellow, Andrew Murray, who has been funded by a generous grant from the Cruden Foundation.

The triennial conference was challenging from a financial perspective and we are therefore in the process of reflecting on the best model for future educational events. There is a sense that more specific one or two day meetings within the College may be the way forward both educationally and financially.

This year we have made a determined effort to engage with our constituencies both within and beyond the UK. Meetings in the Middle East, Singapore, Auckland, Harrogate, Portsmouth and Inverness are all testimony to that. My attendance at the Association of Surgeons in Training meeting in Belfast subsequently led to plans for this meeting to come to Glasgow in 2015 for the first time. We also launched our very successful livelinked 5-day dental course to India without a hitch. It is gratifying to see these initiatives reflected by a progressive increase in numbers of Fellows and Members.

We have continued to contribute to the key issues facing our health service. This includes input to the implementation of the Greenaway Shape of Training Report, lobbying for a reversal of the current move to only one SPA session, addressing the challenges of EWTD and advancing a sustainable plan for unscheduled care.

We have also recently published the outcome of our symposium and survey on 7 day working.

We are doing everything to maximise use of our building through regular review of how we use the facilities. However, it has become clear that office and storage space are at their maximum. We have recently been looking at properties which will enhance our mission statement.

Any purchase would also have to fit in with the current building and be suitably located. We have recently identified such a building and have been successful in purchasing it. We believe it will give us that vital additional space for expansion while also broadening our investment portfolio.

I am confident that 2015 will see continued growth in all our key areas of activities, as well as progressing our commitment to strategically supporting our charitable objectives.

Our members have free access to the online CPD diary of the Federation of Royal Colleges of Physicians of the UK as part of their membership benefits package. The CPD diary delivers the requirements for revalidation and stores information for annual appraisal.

#### Surgeons portfolio

Our members have free access to the surgeons portfolio which enables them to record all aspects of clinical training and practice, professional development activities, peer analysis and audit tools which are tailored to specialty requirements and will deliver the requirements for revalidation. The surgeons portfolio has been created in partnership with the surgical Royal Colleges in Edinburgh and London.

#### **Dentists portfolio**

All dentists must maintain their own CPD records and must submit an annual statement of CPD hours completed to the General Dental Council. We offer a free online CPD portfolio for members of our Dental Faculty.

As one of only five multidisciplinary Colleges in the world, and unique in the UK, we participate in several intercollegiate collaborations spanning dental, medical and surgical disciplines providing assessment services at Membership, Specialty Membership (dentistry) and Fellowship level (Specialty Certificate level for MRCP(UK)).

Through regular participation in assessment activity, examination development and contributions to intercollegiate committees and examination boards, we can ensure high standards are maintained through the application of rigorous standard setting and quality assurance processes in compliance with national regulatory body requirements. Membership of key executive committees enables participation of College Office Bearers in key debates relating to quality standards, governance and due diligence.

Performance in our examinations is monitored through the support of assessment specialists and statistical analysis is utilised to validate the robustness, fairness and equity of examination outcomes. Intercollegiate working produces a sufficiently large body of evidence to substantiate methods or, indeed, prompt consideration of change. In addition, development of specific assessments is progressed as the need is identified and statistical monitoring ensures worldwide parity of standards.

Candidates rely on success in these assessments at key stages in their training for career progression in Great Britain and Ireland. Further, our examinations are recognised around the world as providing quality benchmarks of achievement, building on a long tradition of acknowledged excellence.

The MFDS OSCE examination is now firmly embedded in our centre in the north-west of England attracting a high number of candidates.

To address growing demand, an extra diet will be held in Manchester in February 2015. We look forward very much to welcoming our new Members to the College in the near future.

Internationally, in collaboration with the Maulana Azad Institute of Dental Sciences in New Delhi, we offered the MFDS Part 1 exam, preceded by attendance at our preparatory course streamed live from Glasgow. This has generated much interest from other areas of India and further expansion is planned.



# MRCP(UK)

The Federation of Royal Colleges of Physicians of the United Kingdom continues to offer examinations that set internationally acknowledged standards in medicine. The Specialty Certificate Examinations are now embedded as a requirement for specialist physicians in the UK, also providing an international benchmark for postgraduate medical education.

Increasing demand from international candidates has led to expansion of the number of international centres hosting PACES, the clinical component of the MRCP(UK) Diploma, most recently in Brunei, Myanmar and Qatar. Stakeholder consultation and funded research continue to inform developments, ensuring MRCP(UK) examinations remain relevant to the modern workplace and fit for purpose.



Maintaining standards



#### **MRCS**

Following the introduction of the MRCS OSCE examination for the UK in 2008, the exam has been progressively refined to achieve the highest standards of assessment, recognised by the General Medical Council.

The international version (MRCS OCC) is now in a final withdrawal phase and will cease from January 2016. We have collaborated with the other surgical Royal Colleges and been involved in examiner training to the new OSCE format in Dubai, Fujairah, Muscat and New Delhi.

In the future, only one examination will exist, achieving the highest standards of quality and assessment.



# **JSCFE**

The international version of the FRCS examination – the Joint Surgical Colleges Fellowship Examination (JSCFE) – continues to flourish. Following successful worldwide online testing via Pearson Vue for General Surgery, the first clinical section was held in Al Ain, UAE last year and a second diet held in Colombo, Sri Lanka in Autumn 2014.

There has been progress from the other specialties with neurosurgery, urology, trauma and orthopaedics and cardiothoracic surgery now beginning to offer examinations via the JSCFE website.

# Promoting the best standards of patient care and clinical practice is key to our work.

Our College is a living organisation of clinicians who have firsthand experience of the issues affecting today's clinical services and whose work within the College reflects this.

The appreciation that quality clinical care also requires quality of training, teaching, research and audit, and contribution to service development and management has underpinned our strong support for the true recognition of this work as part of consultant contracts.

Recognition of a need to better fit clinical services around patients has prompted our call for a practical approach to the adoption of seven day services, tailored to what is needed to optimise clinical decision making and thereby treatment and discharge throughout the week.

### **Assisted Suicide**

Members of College Council and the Lay Advisory Board gave careful consideration to the Assisted Suicide Bill 2014.

The Bill raises complex ethical, moral and personal issues and the College, like any other body, is not able to represent institutionally the individual views of all our Fellows and Members.

The overwhelming view of our College Council, submitted both orally and in writing was one of opposition to the Bill.



## European Working Time Directive

We have responded to several consultations on the impact and implementation of the European Working Time Directive on the NHS.

Among the issues highlighted, the College:

- expresses concern that effective quality training cannot be delivered within the time currently allocated for training
- stresses the importance of continuity of contact between a trainee and both their supervisor and patients
- believes that the number of staff required to meet EWTD restrictions could impact on care, particularly in district general hospitals

The trainees' committee consensus also expressed concerns around some issues. These include:

- separating training time from working time
- encouraging trainees to opt out of the EWTD

# Media engagement

The first PR strategy and action plan was approved by the Executive Board in August 2013. In the first year of strategic engagement with the media, the College has:

- issued 23 media statements/media releases
- · been mentioned or the focus of 16 articles in mainstream media
- seen a 30% increase in Facebook followers (currently at 6,160) and a 101% increase in Twitter followers (currently at 1,025) since January 2014
- supported media training for eight individuals
- joined communications planning groups at Academy and Federation level

Key topics on which we have actively spoken out on include:

- shortage of hospital beds
- · supporting the acute take
- time for Scotland to lose the sick man image
- · cigarette packaging
- shape of Training
- the working week seven day working and consultant contracts



# **Lay Advisory Board**

The College holds lay involvement as being tremendously valuable and is committed to there being a clear lay presence across its work.

With the President's support, the College has introduced Lay involvement across its Committee and Board structure. Lay Advisory Board Members support the College by bringing impartial views to committee business and an assurance of transparency.

The Lay Advisory Board continues to look forward to an increasingly active role in College by contributing to exam and education development by bringing the experience of its non-medical members to the discussions and enabling transparency and involvement on the College's Boards and Committees.

The Lay Advisory Board has also contributed to a number of consultations in the past year including:



- Academy of Medical Royal Colleges: Medical Innovation Bill
- Alcohol Health Alliance: Consultation on drink driving statistics
- Scottish Government: Proposed Organ and Tissue Donation (Scotland) Bill
- General Medical Council: Sanctions guidance, apologies and warnings of its non-medical members to the discussions and enabling transparency and involvement on the College's Boards and Committees





Challenge

Forty five people with type 2 diabetes in the existing NHS Greater Glasgow and Clyde "Live Active" programme, which is an individualised intervention to encourage increased participation in physical activity, were enrolled in the Beat Diabetes challenge. Unique to Beat Diabetes, all 45 participants started at the same time, and additional facilities were provided, including three motivational meetings, tokens to help purchase sportswear, and the ability to try out some sporting activities including cycling and running.

Five of the Beat Diabetes participants took part in the 5K run as part of our Advancing Excellence in Healthcare 2014 triennial conference.

of these participants had previously undertaken no physical activity.

Annual Review 2014

As part of "Live Active", participants return to see what changes they have made in physical activity, and how this has affected weight, heart rate and blood pressure. Additionally, as part of Beat Diabetes, the participants are being followed through the Scottish Care Information-Diabetes Collaboration (SCI-DC) database to document changes in glycaemic control, drug usage, and lipids.

By publicising Beat Diabetes we will spread the message that all people with type 2 diabetes can increase their physical activity to the benefit of their health and well being.



# **Admission Ceremonies**


More than 300 new Fellows and Members were welcomed to the College at admission ceremonies held in June, October and November 2014.



# **The College Library**

The College Library has maintained a high level of customer service, replying to all enquiries within two working days. From January to August 2014, the library had responded to 1,540 enquiries and welcomed 1,063 visitors. Highlights from the library this year include:

## Revalidation

In the UK, it is estimated that 224,000 doctors will need to complete revalidation. Since the introduction of the new system in December 2012, the General Medical Council has received approximately 41,000 revalidation recommendations and 8,500 deferral recommendations.

Our revalidation helpdesk continues to support our Fellows and Members with any enquiries they have in relation to revalidation. The most common enquiries are:

- How can locum or "orphan" doctors identify a designated body and Responsible Officer?
- Do doctors practising outside the UK need to revalidate?
- Is there a minimum amount of clinical/ward time necessary to meet revalidation requirements?
- How much supporting information do I need to take to my appraisal?
- Do retired doctors involved in medico-legal work need to revalidate?
- How can doctors access revalidation e-portfolios?




# **Enhancing our communications**


The ongoing enhancement of communications with our members has resulted in three key achievements in 2014:

# New subscription rates





# Reaching out, welcoming in

Our College is a charity committed to ensuring the highest standards of healthcare are met.

In 2014 we achieved our aims of engaging in charitable activities that will contribute to the improvement of health and the raising of standards in healthcare by supporting the Kenyan Healthcare Outreach Programme, the delivery of surgical skills training in Rwanda by the Association of Surgeons in Training, the Needy Little Hearts project of the KJ Research Foundation, the Beat Diabetes Glasgow 2014 Legacy project, and the South West Scotland RnR project.

Members of the public were welcome to a number of events in the College, including talks organised by our College Library and our annual public lecture series. We were delighted to welcome school children to our annual young people's lecture and our 'So you want to be a doctor?' event. Our events company Fifteen Ninety Nine continues to expand and excel and was the venue for seven weddings in 2014.



# Kenyan Healthcare Outreach Programme



Travel Medicine course manager, Ann McDonald MFTM RCPS(Glasg) was supported by the College's charitable committee for the Kenyan Healthcare Outreach Programme.

In rural Kenya around 70% of people live below the poverty line. Many have limited access to sanitation, clean drinking water, healthcare and

education. Many children live in poor conditions and suffer from debilitating illnesses such as TB, HIV, malaria and intestinal worm infestations causing delayed development and chronic illnesses. Those particularly at risk are children under five years of age.

The Outreach Programme was initiated in 2011 after an approach by Kenyan healthcare professionals for assistance in providing much needed healthcare for rural communities. In response, 19 nurses offered their services through the journal of Nursing in Practice. 2014 was the third opportunity to support this Outreach Programme.

As part of the team Ann and her colleagues provided generic healthcare for the communities with particular focus on treating jiggers - tiny fleas that live in the soil and burrow into the soles of the feet. This can cause ulceration and in extreme circumstances may lead to amputation as a result of severe infections. Last year the team supplied flip flops to cover the children's feet, preventing re-infection.



# Surgical skills in Rwanda

We were delighted to support the Association of Surgeons in Training in running a version of the Foundation Skills in Surgery course in Kigali, Rwanda to local medical students and doctors.

The standard of medical training in Rwanda is not as advanced as the UK, and their medical staff are often called upon to perform procedures beyond their capabilities. The surgical skills course was organised to promote basic surgical skills and practices which will benefit local medics and their patients, and put the medical professionals in a good position for further advanced practice.



# Staff charity

Every year the College staff select a charity to support. In 2013 and 2014, funds were raised and donated to Yorkhill Children's Charity during a number of events which ranged from breakfast rolls in the College to the Clinicians on the Clyde 5k fun run. Glasgow foodbanks have been selected as our new charity for 2014/2015.



# Engaging with young people

We welcomed approximately 200 school children from 71 schools to the College in June at our annual "So you want to be a doctor?" event. A number of speakers explained what life is like as a medical student, trainee doctor, hospital specialist and general practitioner.

Our annual young people's lecture in December attracted fifth and sixth year school children who are considering a career in medicine. General and colorectal surgeon Mr Graham Sunderland presented the lecture to the 200 students who attended and was a wonderful inspiration to the next generation of clinicians.


# Doors open day

Our investment portfolio continued to perform well under the guiding hand of Mike Wilson from stockbrokers Speirs & Jeffrey and provided an income of £503k.




We enter 2015 in excellent financial shape and look to consolidate our strong position further by expanding the College and diversifying our investments.

# Faculty of Pharmaceutical Medicine

The Faculty was founded in 1989 with the purpose of advancing the science and practice of pharmaceutical medicine for the benefit of the public. Throughout 2014 we have been celebrating our 25th anniversary with a series of special projects and events designed to reflect on the development of pharmaceutical medicine over the past 25 years and look to the future of medicines development.

The Faculty has been developing Good Pharmaceutical Medical Practice. Based on the GMC's Good Medical Practice, the document provides guidance for all those involved in pharmaceutical medicine around the world on expected standards, conduct and behaviour. The results of a survey of the Faculty's membership showed a very high degree of support for the registration of clinical trials and increased access to trial data, and this has informed our ongoing policy work in this area. The Faculty also continues to act as the designated body to over 500 pharmaceutical physicians undergoing revalidation.

The FPH manifesto, Start Well, Live Better, represents what our members believe to be those priority areas that will not only improve people's health and wellbeing, but will save lives, and give our children and young people the best possible chance of achieving a healthy future.

#### Give every child a good start in life

- Give all babies the best possible start in life by implementing the recommendations of the 1001 Critical Days cross-party report
- Help children and young people develop essential life skills and make Personal, Social, Health and Economic, and Sex and Relationship Education a statutory duty in all schools
- Promote healthy, active lifestyles in children and young people by reinstating at least two-hours per week of physical activity in all schools

# Introduce good laws to prevent bad health and save lives


- Protect our children and young people by stopping the marketing of foods high in sugar, salt and fat before the 9pm watershed on TV, and tighten the regulations for online marketing
- Introduce a 20% duty (per litre) on sugar sweetened beverages as an important measure to tackle obesity and dental caries – particularly in children and young people
- Tackle alcohol-related harm by introducing a minimum unit price for alcohol of at least 50p per unit of alcohol sold
- Save lives through the rapid implementation of standardised tobacco packaging
- Set 20mph as the maximum speed limit in built-up areas to cut road deaths and injuries, and reduce inequalities

#### Help people live healthier lives

- Enable people to achieve a good quality of life, and health and wellbeing – give everyone in paid employment and training a 'living wage'
- Reaffirm commitment to a universal healthcare system free at the point of use, funded by general taxation

#### Take national action to tackle a global problem

- Invest in public transport and active transport to promote good health, and reduce our impact on climate change
- Implement a cross-national approach to meet climate change targets, including a rapid move to 100% renewables and a zero-carbon energy system
