

From the President's Office

I recently attended the UK Academy of Medical Royal Colleges Meeting and as always the agenda was daunting. Although much of the discussion was directed to issues within the English NHS there was much of relevance to all four UK nations. I and the other two Scottish Royal College Presidents met with the Chair of the Academy, Professor Terence Stevenson and we emphasised to him the extent of our membership south of the border and also the relevance of many items on the agenda to the Scottish Health Service. Professor Stephenson has accepted our invitation to visit Scotland in the autumn and this we feel will keep the focus of the Academy on Scottish issues as well as those south of the border.

One particular item which attracted discussion was seven day working. There was agreement that this should focus on unscheduled care and ensuring uniformity of care throughout the working week and at weekends and public holidays. It is clearly unacceptable that the outcomes for patients vary depending on which day they are admitted and there are working groups now addressing this whole issue.

There was also discussion about surgical outcome data and general support for the publication of both individual results as well as team/hospital figures. All agreed that the data had to be rigorously assessed, appropriate and tailored to each situation being evaluated.

The Academy also discussed their response to the Robert Francis report and chose to highlight the key issues from the 290 recommendations and how the Academy could ensure the delivery of these issues.

The difficulty among consultants in England in having protected time to contribute to the wider NHS and to College activities has resonance with the 9/1 contracts prevalent in Scotland for several years. In this regard, the Scottish Academy had a most constructive meeting with the Scottish Health Board Chief Executives recently and I do feel there is now support for providing at least two supporting professional activity sessions per week at the time of appointment to consultant grade.

We had an extremely successful day for our diplomates at the Admission Ceremony on 29 May. Over 400 visited the College during the day while a further 140 attended for a celebratory meal after the ceremony. I am sure this a record attendance with both the College Hall and the Alexandra room being filled to capacity. We provided some Scottish entertainment courtesy of the Royal Conservatoire of Scotland to end a special evening.

Since the last issue of College News, I have attended two meetings with the Scottish Cabinet Secretary for Health and Wellbeing. He listened attentively at both meetings, the first with other service leaders and the second on a one to one. He understands our concerns particularly in regard to the whole area of unscheduled care and in recruitment and retention of staff at all levels. In regard to retention of junior staff, this College supports and applauds the StART(Strategy for Attracting and Retraining Trainees) initiative being led by Alistair McLellan. I have sent the Cabinet Secretary a summary of our points of discussion and a follow up meeting is planned in College later this year. I do hope these meetings will result in changes to the benefit of both the NHS and our Fellows and Members.

All our five disciplines continue to thrive. Dentistry is of course well established and there have been a number of important initiatives led by Dr Alyson Wray both in

exams and education. Dr Wray will be completing her term as Vice-President (Dental) and Dean of the Faculty in October and I would like express my sincere thanks and the thanks of the College to her for her many contributions over the past three years.

Dr Mike Jones continues to lead Travel Medicine to excellent effect and our newest Faculty of Podiatric Medicine with Dr Colin Semple at the helm is already making considerable strides both in recruitment and exam development.

5 July was the 65th anniversary of the NHS and this event has rightly been acknowledged throughout the United Kingdom. Despite recent failings, it remains the envy of the world in healthcare delivery. Let us hope that it can adapt to all the challenges which confronts it in 2013 and retain the admirable principles on which it was founded.

7 July 2013 will be remembered for a monumental sporting achievement. Millions of people around the world watched Andy Murray's magnificent win in the Wimbledon final. He made a sunny Scotland even happier on Sunday and into Monday and before anyone asks, no I was not alive to see Fred Perry's win!

£4 million of funding to improve patient safety

The Health Foundation has announced funding totalling £4 million to support up to nine projects that will demonstrate improvements in patient safety by tackling known gaps between best practice and delivery of care.

Each project will receive up to £450,000 of funding to support the implementation and evaluation of tested, evidence-based patient safety interventions at scale. Projects are expected to provide a logical link between an identified patient safety hazard or problem and the proposed intervention.

Projects must demonstrate an impact on patient safety within health or social care. Applications are welcome from people working in primary, secondary or tertiary care, or health and social care settings in the UK.

Suggested types of projects include, but are not limited to:

- Approaches to build skills in improving patient safety
- Interventions to improve reliability of clinical care
- Creating the conditions for the delivery of patient care.

Applications are expected to come from groups of organisations working together and should demonstrate a strong track record in designing, delivering and evaluating improvement projects.

Projects will also need to include an organisation that can influence wider practice and opinion.

The closing date for applications is 12 noon, 23 September 2013.

Medical Training Initiative

We continue to be active in forging links with UK and international institutions in promoting the Medical Training Initiative (MTI) and highlighting the potential benefits to trainees, receiving hospitals and the main long-term beneficiaries of the scheme, the health services in participant's home countries.

A recent publicity and marketing drive resulted in the establishment of links with Wrightington, Wigan and Leigh NHS Trust, Barnsley NHS Trust and North Lincolnshire NHS Trust. The presence and work of our regional advisors in these areas, Dr Asif Naqvi and Dr Jean-Pierre Ng Ping Cheung, contributed hugely to this progress and it is anticipated that, following a similar model, further MTI development will take place in England. We are also very active in Westonsuper-Mare and currently have six doctors

in this Trust in training positions covering a range of specialties.

At the June meeting of the MTI College leads, the main agenda item was the revision and re-drafting of MTI supporting documentation in order to make the process (often considered too bureaucratic) more streamlined and efficient. This documentation has now been formally approved and will shortly be available to all scheme participants.



Dr Alyson Wray: term as Vice-President coming to an end

Dr Alyson Wray, Vice-President (Dental) was the first female Vice-President of any UK Royal College. She is also a consultant paediatric dentist and hospital postgraduate tutor for National Education Scotland.

For the past three years Alyson has served as Vice-President (Dental) and Dean of the Faculty of Dental Surgery. In that time, she has overseen a huge amount of progress in the Faculty and our voice in shaping the future of patient care in dentistry has never been stronger.

Among her achievements are helping to drive forward the development of tri-collegiate membership exams in oral surgery, special care dentistry and paediatric dentistry, all of which were launched in the UK last year. The hope now is to take these exams to international centres. Alyson has also been working hard to ensure the highest standards are maintained on the bi-collegiate examinations in orthodontics and restorative dentistry.

Under her guidance, the Faculty of Dental Surgery has pioneered the College's first trainee package, designed to help trainees combine the costs of education,



examination and membership into regular monthly payments. The MFDS examination continues to be internationally recognised as a benchmark qualification for dental professionals and we are currently running the MFDS Part 1 examination in 12 centres, five of which are outside the UK. The MFDS Part 2 examination is run in Glasgow and Manchester.

Everyone at the College wishes Alyson the very best for the future and we thank her

for the huge contribution she has made both to the Faculty of Dental Surgery and the wider College.

Professor Richard Welbury will take over as Vice-President (Dental) and Dean of the Faculty following the Faculty AGM in October.

Revalidation update

Our College continues to contribute to the wider revalidation debate and is represented in a range of Scottish and UK forums. The Academy of Medical Royal Colleges Revalidation Steering Group (ARSG) June meeting focussed on two key areas which could impact on Fellows and Members as a result of the new system of appraisal and revalidation:

Remediation

The Academy of Medical Royal Colleges (AoMRC) has consulted widely with a range of partners to assess how best to support those doctors who may require support, should performance issues come to light during appraisal. A remediation implementation group has been established with the remit to produce a process map outlining the role played by Colleges and how, in partnership with other key agencies, the necessary support

and resources can be identified to ensure that doctors going through remediation are given every opportunity to return to full practice.

SAS surgeons

Concerns have been raised that specific groups such as SAS surgeons are often faced with significant challenges relating to local organisational systems of appraisal and clinical governance, which make it more difficult for them to access the resources necessary for meeting the full requirements of revalidation.

Future activities

Our College sits on the Academy of Medical Royal Colleges (AoMRC) Specialties Guidance Group (SGG), which has been instrumental in the development and drafting of supporting information and guidance frameworks for revalidation.

To assess the usefulness of the range of support tools available to doctors the SGG will conduct a survey of doctors, appraisers and responsible officers in the autumn. Questionnaires will be issued to all doctors who have participated in the first year of the new system and Fellows and Members are asked to respond to ensure your College's views are represented in the survey results and conclusions.



What your College is saying

We are frequently asked to comment on issues in the media. There are many different views among our 10,000 plus strong membership and we do our best to put forward logical, informed and appropriate responses to best represent you. Below are some recent issues that we have commented on.

13 May

Nurse to patient ratios

In May, we supported a proposal from the Safe Staffing Alliance to standardise nurse to patient ratios in the NHS. Care of patients deteriorates when both nursing and medical staff numbers are stretched. We believe the drawing up of unequivocal standards of nursing numbers in the different types of wards using benchmarking and the expertise that is available is worthy of consideration. Having these numbers independently monitored would close the door to inappropriate budgetary savings in this area and thereby eliminate the risk to patient safety and care.

24 June

Consultant rotas

For many years consultants have been present in the hospital on a rota system for parts of weekday evenings and at weekends as well as being on call overnight both during week nights and weekends. We believe there is a need to put in place a consistent standard of care which is of the highest quality throughout the working week, at weekends and on public holidays and this issue is currently being addressed by the Royal Colleges in the United Kingdom along with the Scottish Academy. We support the need for consultants in some specialties to be on site both in the evenings and at weekends and believe a move towards extending elective work to evenings and weekends is worthy of considering. However, we recognise this would have substantial resource implications not only for doctors but also for the many other health professionals who work within the NHS. Such a move would have to be balanced against other pressures within the service, bearing in mind financial and other constraints. Ensuring a uniform standard of care for acutely ill patients would seem to be a reasonable initial requirement.

25 June

An opt out system for organ donation

In June, the BMA Scotland launched a campaign to highlight the importance of organ donation and the impact it can have on people's lives. They have proposed introducing an opt-out system for organ donation in Scotland. An opt-out system has already been implemented or is being planned in a number of countries around the world. We support an opt-out system for organ donation and believe it will save many lives.

5 July

NHS 65th birthday celebrations

We were delighted to be involved with the NHS 65th birthday celebrations. Recent events have demonstrated the need to keep the patient central to the service and not to let other considerations divert from that focus. We recognise there are major quality, financial and workforce issues at present, but there is also a strong will among the public, within the Royal Colleges and other medical institutions and the government to maintain this most important of institutions. As a small gesture of appreciation on this special occasion,



our chef baked a beautiful birthday cake which we gave to the staff at Yorkhill Children's Hospital in Glasgow in appreciation of the great work they do.

Nutrition for the less initiated

On a day to day basis, most of us are interested in nutrition – we choose the restaurants we eat in and select our food with care. We intuitively agree that nutrition is important.

In the past twenty years there have been times when nutrition in hospitals was relegated to a "hotel service" of no interest to the medical and nursing staff. However, there has recently been a renaissance of interest in our patients' nutritional status. The stimulus to this has varied from the intriguing physiology of nutrition - carbohydrate loading dampening the metabolic response to surgery or the cure of diabetes by obesity surgery — to the ability to support patients through critical illness and major surgery with artificial nutrition either enteral or parenteral.

Our nursing and dietetic colleagues have developed screening protocols for malnutrition which are now routine. This has led to an increasing demand for gastroenterologists and GI surgeons who understand the physiology of the metabolic response and who are capable of delivering safe nutritional care.

The day has now come where the training syllabi for both specialties makes nutrition a specific topic to be covered.

Our College has developed a new one day course aimed principally at gastroenterology and GI surgery senior trainees and consultants which covers nutrition for those interested in, but less familiar with, its practice in medicine. The day starts with a plenary session addressing the metabolic response to starvation and disease which is followed by a workshop on identifying malnutrition. Delegates will be able to choose two of three themes during the middle part of the day – enteral or parenteral nutritional support and obesity. There will also be interactive small group workshops addressing practical aspects of how this care is provided. The day finishes with the challenge of goal setting and monitoring in nutrition.

The cost of glaucoma

As we approach eye health week in the UK (16-22 September), **Donald Montgomery FRCP(Glasg) FRCS(Glasg) FRCOphth** reports on new research that looks at the economic burden of glaucoma management.

Glaucoma is a leading cause of blindness estimated to affect more than 70 million people around the world. In the UK, the prevalence of glaucoma has been estimated to be as high as 3.3% in people over the age of 40 and up to 5% in those over 80.

The treatment of glaucoma has significantly improved in recent years with the introduction of better drugs yielding fewer side effects. Surgical treatments have also developed and are contributing to the retention of sight for people affected by the condition.

As a major health problem with a continuous demand for treatment that may be medical or surgical, the management of glaucoma has considerable economic consequences. However, until recently, no studies had looked directly at the lifetime costs associated with managing the condition.

We have now published the first report to evaluate both the drug and non-drug costs (hospital visits, surgical procedures, etc) of glaucoma over a patient's lifetime.

With the benefit of access to the Glasgow Glaucoma Database, which currently holds complete treatment histories on 1136 patients spanning 27 years, we were able to identify more than 100 patients who had initiated treatment for glaucoma at Glasgow Royal Infirmary and have subsequently died of natural causes. This provided us with data on a cohort of patients who attended the clinic with glaucoma and who had lifetime healthcare resource use data.

We found that on average patients with glaucoma attended the clinic for about seven years, ranging in total from one year to 22 years. The average cost of treatment was £475 per year, or £3001 per lifetime. The non-drug costs were almost double the drugs costs and the need for surgical procedure clearly had an impact on higher costs.

We further investigated the costs associated with different types of glaucoma and with ocular hypertension.

Primary open angle glaucoma (POAG) was much more prevalent than normal tension glaucoma (NTG) of ocular hypertension (OHT), accounting for almost three quarters of all the patients included in the study.

Patients with a diagnosis of POAG had an average of 1.9 surgical procedures during their lifetime, accounting for 88% of all

surgeries reported. This also led to higher average costs associated with POAG when compared to the other diagnoses. The average lifetime cost for patients with POAG was close to £4000, compared to approximately £2000 for patients with NTG or OHT.

Awareness of the economic impact of glaucoma is important in these financial hard times, as governments choose to tighten health budgets. We hope that understanding of the financial cost of the condition will help to inform clinicians and policy makers on the economics of managing glaucoma.

My College

Although I was an undergraduate at the University of Glasgow, qualifying in 1982, it was not until the following year that I first set foot inside the College. I remember distinctly the feeling of apprehension as I sat outside the doors of College Hall, waiting my turn to face the examiners in the Primary FRCS orals. This was at a time when even budding ophthalmologists were expected to have a detailed knowledge of the anatomy of the foot. Fortunately the examiners were sympathetic and allowed me to pass on my first attempt.

As a trainee I benefited greatly from the ophthalmology symposia held each Spring and Autumn in the College. In 1990 I was privileged to share the podium with Harry Quigley as he delivered the William Mackenzie Lecture. That meeting led to an observership with Harry at the Wilmer Institute at Johns Hopkins in Baltimore. This was a formative experience that confirmed my interest in glaucoma as a subspecialty and three years later I was appointed consultant at Glasgow Royal Infirmary to run the glaucoma service there.

Shortly afterwards I was asked to join the panel of examiners for the ophthalmology



FRCS examination and I found it quite a different experience to sit in College Hall on the opposite side of the desk!

Later I was invited onto the Advisory Committee tasked with overseeing the examination, as well as organising the ophthalmology and optometry symposia.

Several years as secretary to the Committee were followed by a period of chairmanship. This was a particularly interesting time as examinations were being redesigned to satisfy the more stringent requirements of Post Graduate Medical Education Training Board (PMETB). New responsibilities, including chairmanship of the West of Scotland Specialty Training Committee for Ophthalmology, meant that I had to eventually relinquish my role on the Advisory Committee.

However I remain committed as an examiner and I am pleased to see the ophthalmology FRCS going from strength to strength with demand from candidates, especially from the Middle East, continuing to rise.



Foot and ankle ultrasound


Ultrasound has been shown to be particularly beneficial in the foot and ankle where complex anatomy, small joint spaces and close lying structures may hamper accurate clinical assessment.

A practical study day on ultrasound examination of the foot and ankle will be held by the College in partnership with colleagues from the Scottish Rheumatology Ultrasound Group and Glasgow Caledonian University.

This one-day intensive practical study day within our clinical skills study laboratory will be blended with a series of educational resources delivered via a virtual learning environment. The course is intended to provide a basic introduction to ultrasound techniques in the foot and ankle and is aimed at those with little or no experience of ultrasound scanning.


