# SECTION 2 Job Purpose

(Overall objectives of the role)

Medical trainees are required to pass the three-part MRCP(UK) examination as a condition of entry into specialist internal medicine training in the UK. MRCP(UK) PACES is the clinical element of this Assessment, comprising of five exam stations.

Station 2 and 5 is the Integrated Clinical Assessment station, designed to examine the candidates' ability to address a clinical problem using a combination of focused history taking, examination, and communication skills with a patient in a way that reflects daily clinical practice.

The RCPSG PACES Station 2 and 5 Vetting Group comprises approximately five Senior Clinicians responsible for the review of scenarios submitted by Glasgow centre Host examiner, to ensure compliance with clinical and editorial standards.

Glasgow college delivers approximately 120 cycles of the MRCP(UK) PACES examination per annum, for which approximately 70 Station 5 clinical scenarios are needed.

## **SECTION 3** Dimensions

(Information which helps in understanding the context and scale of the role)

- To be eligible for appointment applicants must be a compliant PACES Examiner with a minimum of 1 year's experience.
- Applicants must normally be a Fellow or Member of RCPSG in good standing with the College and the GMC.
- Members of the Station 2 and 5 Vetting Group will be expected to maintain active participation at MRCP(UK) PACES examinations, usually three examiner days per year

### **Examination**

- MRCP(UK) PACES diets as usually delivered three times per annum, January to March, June to August and September to December.
- The bank of Station 2 and 5 scenarios is continually replenished throughout the year.
- Station 2 and 5 is delivered with the assistance of patient volunteers. For this reason, scenarios
  are sometimes subject to short notice revision and may require the input of the Vetting Group
  members with short turn-around.

### Committee membership

### <u>Collegiate – per annum</u>

- The Station 2 and 5 Vetting Group will meet regularly throughout the year as directed by the Group Chair.
- Members of the Station 2 and 5 Vetting Group are responsible to raise matters of relevancy to the Medical Examinations Board, Station 2 and 5 Vetting Group Representative prior to each Board meeting.

#### Intercollegiate – per annum

 Members of the Station 2 and 5 Vetting Group are not required to attend intercollegiate meetings.

- Expert clinical and editorial review of Station 2 and 5 scenarios, in compliance with MRCP(UK) guidance and regulations.
- Work closely with the other members of the Station 2 and 5 Vetting Group
- To advise the Station 2 and 5 Vetting Group Lead Representative on matters of relevancy prior to Medical Examinations Board meetings
- To work cooperatively with the Medical Examinations Manager and the Examinations Coordinators.
- If requested, to provide clinical input to consultation documents received from external bodies (e.g. NHS, NES, GMC etc)
